India & Georgia Relations

In 2019, India and Georgia signed a joint program on a Free Trade Agreement (FTA), elevating their diplomatic friendship and opening up significant opportunities for business and professional education for Indian students

Direct Flights from India to Georgia:



The countries have established fast air connectivity through an Air Services Agreement (ASA) signed in Delhi. Indian carriers can fly to any point in Georgia, while Georgian airlines operate directly to six Indian cities: New Delhi, Mumbai, Bengaluru, Hyderabad, Chennai, and Goa. These direct flights and the 'Open Sky' regime promote stronger business ties, economic growth, and accessibility—especially benefiting Indian students in Georgia.
